NOTE: D.R.Y.A. applicants must pay a SUSTAINING, FAMILY or COLLEGIATE Membership Fee. All boat owners wishing to race must pay the REGISTRATION FEE. **There is a \$10 REGISTRATION credit for US Sailing Members; they require this differential for insurance.** Proof of membership is required (copy of card or mailing label). Since D.R.Y.A. is a 501(c) (3) charitable organization dues (not registrations or other charges) should be tax deductible in accordance with provisions of the IRS code.

MEMBERSHIP CATEGORIES

Sustaining Members - a person whom is a member in good standing of a Member Club or an Affiliated Sailing Organization shall be eligible to become a Sustaining Member of the Association.

Family Members: A person who is the child under the age of 21 or the spouse of a Sustaining Member shall be eligible to become a Family Member of the Association.

Junior Members: A person under the age of 21 who is a junior member in good standing of a Member Club, a member in good standing of the Association's junior sailing organization or the child of a member in good standing of a Member Club shall be eligible to become a Junior Member of the Association.

Collegiate Members: A person who is an undergraduate member in good standing of a collegiate sailing club that is a member of the Midwest Collegiate Sailing Association shall be eligible to become a Collegiate Member of the Association.

Associate Members: A person who is not otherwise eligible to become a member of the Association but has an interest in sail racing and the activities of the Association and its Member Clubs shall be eligible to become an Associate Member of the Association.

Contributing Members: A person who is eligible to become a member of the Association and who pays specified dues in an amount greater than those established by the Executive Committee for any other category of individual membership shall be eligible to become a Contributing Member of the Association.

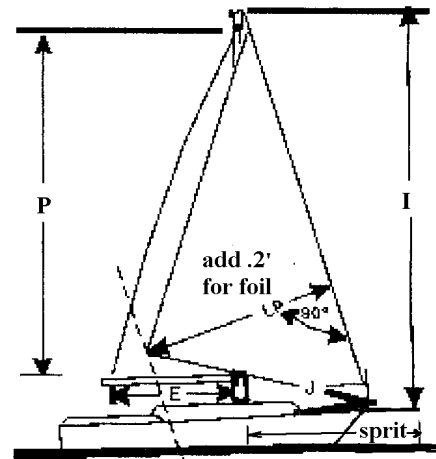

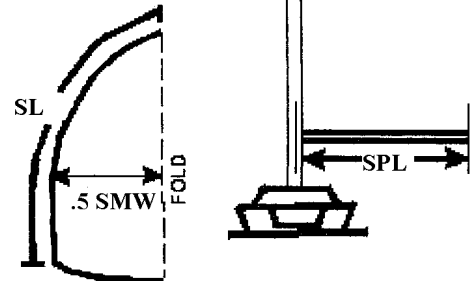
